TO PASSENGERS

This delivery check is issued by the Atchison, Topeka & Santa Fe Railway Co. solely for the accommodation and at the request of the passenger and the carriers shall not be liable for any loss of, injury or delay to baggage, after delivery at railroad destination to Transfer Co.

This duplicate is simply a receipt and becomes void upon delivery of the baggage to owner, or at address shown on face.

Property for which this check is issued is transported subject to tariff regulations.

If charges for excess weight or size or any other charges accruing on baggage before this check is issued, are not paid at checking station, they will be collected at destination.

If there are no baggage delivery facilities at destination baggage must be claimed at railroad station.

Baggage liability is limited to wearing apparel not exceeding \$100.00 in value on a whole (adult's) ticket and \$50.00 on a half (child's) ticket, unless at time of checking a greater value is declared and paid for.

TO ISSUING AGENTS

This check is to be used only when checking baggage through to address at destination, such as residence or hotel. Passenger should be informed that charge for delivery at destination will be collected by the delivering Transfer Company.

TO AGENT AT DESTINATION

Immediately on arrival of this piece of baggage separate string check at line following "Delivery charges not paid," and deliver baggage at once to transfer company, taking their receipt, showing check number, name of issuing line, date and time, and instruct them to collect delivery charges from consignee.

If owner desires to surrender duplicate of this check and claim baggage at terminal railroad station, it may be delivered if it has not already been given to transfer company.

If a C.O.D. is also attached to baggage with this check, agent must collect amount from the Transfer Company before surrendering baggage, giving receipt therefor.

If an Excess Check is also attached to baggage, Agent must detach it before delivery to Transfer Company.

Agent at destination will retain this portion 90 days for reference.
