The State of Pennsylvania assesses a sales and use tax of 6% on food, cigarettes and beverages other than alcoholic, also a 5% tax on cigars. The State of North Carolina assesses a sales tax of 3% on all meals and food items. The State of Florida assesses a tax of 4%; the States of Georgia and South Carolina and the Commonwealth of Virginia assess a tax of 3% on all sales. The State of New Jersey assesses a sales and use tax of 3% on all sales other than alcoholic beverages. All taxes must be collected from the buyer in each state.
